### **From Pitt to Peel 1783–1846**

- 1 How successful were Pitt the Younger's domestic policies? [50]
- 2 'Government policies were the most important reason for the failure of the radical challenges in the period from 1812 to 1822.' How far do you agree? [50]
- 3 'The fear of revolution was the most important reason for the passing of the Great Reform Act in 1832.' How far do you agree? [50]

### **Liberals and Conservatives 1846–1895**

- 4 Assess the reasons for the political domination of the Whigs and Liberals in the period from 1846 to 1868. [50]
- 5 'The loss of the support of non-conformists was the most important reason for the defeat of the Liberals in the 1874 election.' How far do you agree? [50]
- 6 How far did Disraeli achieve his aims in foreign and imperial policies in the period from 1874 to 1880? [50]

### **Foreign and Imperial Policies 1856–1914**

- 7 How far was British foreign policy influenced by a fear of Russia in the period from 1856 to 1902? [50]
- 8 'Support for imperialism declined from 1880 to 1902.' How far do you agree? [50]
- 9 To what extent did relations with Germany decline during the period from 1902 to 1914? [50]

### **Domestic Issues 1918–1951**

- 10 How successful were the Labour governments of 1924 and 1929 to 1931? [50]
- 11 Assess the reasons for the failure of the General Strike. [50]
- 12 How successful were the reforms of the Labour governments of 1945 to 1951 in solving the social and economic problems they inherited? [50]

**Foreign and Imperial Policies 1945–1990**

- 13** 'Imperial interests were the most important reason why Britain did not join the EEC before 1973.' How far do you agree? [50]
- 14** How much domestic opposition was there to Britain's possession of nuclear weapons in the period from 1945 to 1990? [50]
- 15** To what extent was Britain a great power from 1945 to 1990? [50]

**Post-War Britain 1951–1994**

- 16** How successfully did Macmillan deal with the problems he faced as Prime Minister? [50]
- 17** 'The Labour governments of 1964–1970 were more successful than the Labour governments of 1974–1979.' How far do you agree? [50]
- 18** Assess the reasons for opposition to Thatcher's social and economic policies. [50]
