

Answer any **two** questions.

From Anglo Saxon England to Norman England 1035–1087

- 1 'Edward the Confessor was an effective monarch.' How far do you agree? [50]
- 2 Assess the reasons for the power and influence of the Godwin family during the reign of Edward the Confessor. [50]
- 3 'The military strength of the Normans was the most important reason for their victory at Hastings.' How far do you agree? [50]

Lancastrians, Yorkists and Tudors 1450–1509

- 4 Assess the reasons for the wars between the Lancastrians and Yorkists in the period from 1450 to 1470. [50]
- 5 How successful was Edward IV's management of royal finances? [50]
- 6 How successfully did Henry VII deal with the domestic problems he faced? [50]

Henry VIII to Mary I, 1509–1558

- 7 How successful was Henry VIII in achieving his aims in foreign policy in the period from 1509 to 1529? [50]
- 8 How far did Cromwell's reforms change Tudor government and administration by 1547? [50]
- 9 How effective were the governments of Somerset and Northumberland? [50]

Church and State 1529–1589

- 10 How far did the religious changes under Henry VIII from 1539 to 1547 make England protestant? [50]
- 11 How successful were the religious policies of Mary Tudor? [50]
- 12 'The puritan threat to the Elizabethan church was never serious.' How far do you agree? [50]

England under Elizabeth I, 1558–1603

- 13 How important was the Court in government during the reign of Elizabeth I? [50]
- 14 How serious were the financial and economic problems during the reign of Elizabeth I? [50]
- 15 'Elizabeth I's popularity declined dramatically after 1588.' How far do you agree? [50]

The Early Stuarts and the Origins of the Civil War 1603–1642

- 16 'The conflicts between James I and his parliaments were never serious.' How far do you agree? [50]
- 17 'Charles I's personal rule brought stability to England in the period from 1629 to 1640.' How far do you agree? [50]
- 18 How far was Pym to blame for the outbreak of the Civil War in 1642? [50]
