- 1. What is the last date I can enter candidates? 30/6/14
- 2. What is the last date I can certificate candidates? 30/6/17
- 3. I have DCS / ACS how does this affect the last certification / assessment dates? Not applicable to this qualification as it's moderated.
- 4. We are a Welsh centre / in NI are we affected in the same way? Yes, the same arrangements will apply to Wales/NI as to England.
- 5. Why is OCR withdrawing this qualification?
 Following a review of our qualification offer in the light of falling market demand and changes to the funding regime, OCR has reluctantly decided to withdraw the two qualifications listed below. OCR will of course continue to support and assess the qualifications up to the final certification date for this qualification which will be as follows:
