**TRADITIONAL**

**MARKING**

1. Mark strictly to the mark scheme.
2. Marks awarded must relate directly to the marking criteria.
3. The schedule of dates is very important. It is essential that you meet the scoris 50% and 100% (traditional 50% Batch 1 and 100% Batch 2) deadlines. If you experience problems, you must contact your Team Leader (Supervisor) without delay.

5. Work crossed out:
  - a. where a candidate crosses out an answer and provides an alternative response, the crossed out response is not marked and gains no marks

  - if there is nothing written at all in the answer space
  - OR if there is a comment which does not in any way relate to the question (e.g. 'can't do', 'don't know')
  - OR if there is a mark (e.g. a dash, a question mark) which isn't an attempt at the question.Note: Award 0 marks – for an attempt that earns no credit (including copying out the question).
8. The scoris **comments box** is used by your Team Leader to explain the marking of the practice responses. Please refer to these comments when checking your practice responses. **Do not use the comments box for any other reason.** If you have any questions or comments for your Team Leader, use the phone, the scoris messaging system, or e-mail.
9. Assistant Examiners will send a brief report on the performance of candidates to their Team Leader (Supervisor) via email by the end of the marking period. The Examiners' Standardisation Meeting will ensure that the Mark Scheme covers the range of candidates' responses to the questions, and that all Examiners understand and apply the Mark Scheme in the same way. The Mark Scheme will be discussed and amended at the meeting, and administrative procedures will be confirmed. Co-ordination scripts will be issued at the meeting to exemplify aspects of candidates' responses and achievements; the co-ordination scripts then become part of this Mark Scheme.

Before the Standardisation Meeting, you should read and mark in pencil a number of scripts, in order to gain an impression of the range of responses and achievement that may be expected.

Please read carefully all the scripts in your allocation and make every effort to look positively for achievement throughout the ability range. Always be prepared to use the full range of marks.

**INFORMATION AND INSTRUCTIONS FOR EXAMINERS**

- 1 The co-ordination scripts provide you with *examples* of the standard of each band. The marks awarded for these scripts will have been agreed by the Team Leaders and will be discussed fully at the Examiners' Co-ordination Meeting.
- 2 The specific task-related indicative content for each question will help you to understand how the band descriptors may be applied. However, this indicative content does not constitute the mark scheme: it is material that candidates might use, grouped according to each assessment objective tested by the question. Rigid demands for 'what must be a good answer' would lead to a distorted assessment.
- 3 Candidates' answers must be relevant to the question. Beware of prepared answers that do not show the candidate's thought and which have not been adapted to the thrust of the question. Beware also of answers where candidates attempt to reproduce interpretations and concepts that they have been taught but have only partially understood.

	<b>Generic mark scheme for Section A, Questions 1 and 2: Essay [30]</b>
<b>Level 5</b> 25–30 marks	There is a mostly consistent focus on the question. Generally accurate and detailed knowledge and understanding is demonstrated through most of the answer and is evaluated and analysed in order to reach substantiated judgements, but these are not consistently well-developed. There is a well-developed line of reasoning which is clear and logically structured. The information presented is relevant and in the most part substantiated.
<b>Level 4</b> 19–24 marks	The question is generally addressed. Generally accurate and sometimes detailed knowledge and understanding is demonstrated through most of the answer with evaluation and some analysis, and this is used appropriately to support the judgements that are made. There is a line of reasoning presented with some structure. The information presented is in the most-part relevant and supported by some evidence.
<b>Level 3</b> 13–18 marks	The question is partially addressed. There is demonstration of some relevant knowledge and understanding, which is evaluated and analysed in parts of the answer, but in places knowledge is imparted rather than being used. The analysis is appropriately linked to the judgements made, though the way in which it supports the judgements may not always be made explicit. The information has some relevance and is presented with limited structure. The information is supported by limited evidence.
<b>Level 2</b> 7–12 marks	The focus is more on the topic than the specific demands of the question. Knowledge and understanding is limited and not well used, with only limited evaluation and analysis, which is only sometimes linked appropriately to the judgements made. The information has some relevance, but is communicated in an unstructured way. The information is supported by limited evidence and the relationship to the evidence may not be clear.
<b>Level 1</b> 1–6 marks	The answer relates to the topic but not the specific question. The answer contains only very limited relevant knowledge which is evaluated and analysed in a very limited way. Judgements are unsupported and are not linked to analysis. Relevant knowledge is limited, generalised and poorly used; attempts at argument are no more than assertion. Information presented is basic and may be ambiguous or unstructured. The information is supported by limited evidence.
0 marks	No evidence of understanding and no demonstration of any relevant knowledge.

	<i>AO3: Analyse and evaluate, in relation to the historical context, different ways in which aspects of the past have been interpreted.</i>
	<b>Generic mark scheme for Section B, Question 3: Interpretation [20]</b>
<b>Level 5</b> 17–20 marks	The answer has a very good analysis of the interpretation. It uses detailed and relevant knowledge of the historical context and shows thorough understanding of the wider historical debate, in the form of detailed examination of other interpretations, in order to produce a well-supported evaluation of both the strengths and weaknesses of the given interpretation.
<b>Level 4</b> 13–16 marks	The answer has a good analysis of the interpretation. It uses relevant knowledge of the historical context and good understanding of the wider historical debate, in the form of examination of other interpretations, in order to produce a supported evaluation of both the strengths and weaknesses of the given interpretation.
<b>Level 3</b> 9–12 marks	The answer has a partial analysis of the interpretation. It uses some relevant knowledge of the historical context and shows partial understanding of the wider historical debate, in the form of reference to other interpretations, in order to evaluate the strengths and weaknesses of the given interpretation. The evaluation may be un-even with only limited treatment of either limitations or strengths, but both will be addressed.
<b>Level 2</b> 5–8 marks	The answer has a limited analysis of the interpretation. It uses generalised knowledge of the historical context and shows limited understanding of the wider historical debate, in the form of generalised reference to other interpretations, in order to produce a limited evaluation of the given interpretation. The evaluation may deal with either strengths or limitations in a very superficial way, or may only address limitations or strengths.
<b>Level 1</b> 1–4 marks	The answer has a very limited analysis of the interpretation which may be descriptive and relate more to the topic area than the detail of the interpretation. It uses very limited and generalised knowledge of the historical context and shows very limited or no understanding of the wider historical debate, with reference to other interpretations being implicit or lacking, in order to produce a very simplistic, asserted evaluation of the given interpretation.

1*	<p><b>‘The system of apartheid was never seriously threatened between 1955 and 1978’ How far do you agree with this statement?</b></p> <ul style="list-style-type: none"> <li>• <b>In arguing apartheid was never seriously threatened</b>, answers might comment on the Rivonia Trial and the imprisonment or exile of most of the ANC’s key leaders including Tambo and Mandela in the period 1964–1989.</li> <li>• Divisions between Black South Africans and the difficulties the ANC faced in creating a united opposition movement (answers might highlight the Inkatha Freedom Party, Biko and the South African Students’ Organisation, other forms of popular protest and violence between Black South Africans).</li> <li>• Answers might stress the effectiveness of government suppression of opposition groups.</li> <li>• Answers might contrast the success of the ANC with other organisations and individuals such Tutu up to 1978 and Biko in bringing about change in this period.</li> <li>• <b>In arguing that apartheid was threatened</b>, during this period answers might consider the survival of the ANC through a period of government suppression and the imprisonment and exile of key leaders and the continuity in their aims from the Freedom Charter of 1955.</li> </ul>	30	<ul style="list-style-type: none"> <li>• No set answer is expected.</li> <li>• At Level 5 there will be judgement as to the relative importance of the threats.</li> <li>• At level 5 answers might establish criteria against which to judge the relative importance of the threats.</li> <li>• To be valid, judgements must be supported by relevant and accurate material. If not, they are assertions.</li> <li>• Knowledge must not be credited in isolation, it should only be credited where it is used as the basis for analysis and evaluation, in line with descriptions in the levels mark scheme.</li> </ul>

2*	<p><b>‘The work of the Truth and Reconciliation Commission was the determining factor in bringing about unity in South Africa in the year from 1992 to 1999.’ How far do you agree?</b></p> <ul style="list-style-type: none"> <li>• <b>In dealing with Truth and Reconciliation Commission</b>, answers might point to the spirit of the TRC and of those who would be pardoned for telling the truth and that people were able to face those who did them wrong in order to move on from it.</li> <li>• Answers might suggest there was an opportunity for people to come together and speak out on what happened and for those who asked for forgiveness to receive it, thereby allowing for people to come together in unity.</li> </ul>	30	<ul style="list-style-type: none"> <li>• No set answer is expected.</li> <li>• At Level 5 there will be judgement as to the relative importance of the reasons.</li> <li>• At level 5 answers might establish criteria against which to judge the relative importance of the reasons.</li> <li>• To be valid, judgements must be supported by relevant and accurate material. If not, they are assertions.</li> <li>• Knowledge must not be credited in isolation, it should only be credited where it is used as the basis for analysis and evaluation, in line with descriptions in the levels mark scheme.</li> </ul>

3	<p><b>‘The role that the international community played on the sidelines was of crucial importance in determining the outcome [the end of Apartheid].’</b></p> <p><b>From: A.Guelke, Rethinking the Fall of Apartheid, 2005</b></p> <p><b>Evaluate the strengths and limitations of this interpretation, making reference to other interpretations that you have studied.</b></p> <ul style="list-style-type: none"> <li>• <b>The historical debate about the end of Apartheid raised here centres around the relative importance of domestic/internal vs. international/external factors.</b></li> <li>• <b>In analysing and evaluating the strengths and limitations of the interpretation</b>, answers might mention the focus on the international community specifically, whilst also acknowledging this was on the ‘sidelines’.</li> <li>• <b>In analysing and evaluating the strengths of the given interpretation</b>, answers might use knowledge and understanding of: <ul style="list-style-type: none"> <li>• the impact of sanctions on South Africa</li> <li>• the international isolation of South Africa</li> <li>• the sporting isolation of South Africa</li> </ul> </li> </ul>	20	<ul style="list-style-type: none"> <li>• No set answer is expected.</li> <li>• Candidates must use their knowledge and understanding of the historical context and the wider historical debate surrounding the issue to analyse and evaluate the given interpretation.</li> <li>• Candidates must refer to at least one other interpretation.</li> <li>• The quality of analysis and evaluation of the interpretations should be considered when assigning answers to a level, not the quantity of other interpretations included in the answer.</li> <li>• Other interpretations considered as part of evaluation and analysis do not need to be attributed to specific named historians, but they must be recognisable historical interpretations, rather than the candidate’s own viewpoint.</li> <li>• Answers may include more on strengths or more on limitations and there is no requirement for a 50/50 split in the evaluation, however for level 5 there should be well-supported evaluation of both and for level 4 supported evaluation of both, in line with levels descriptors.</li> <li>• Candidates are not required to construct their own interpretation.</li> </ul>

	<ul style="list-style-type: none"> <li>• the decline of external investment in South Africa and the economic impact</li> <li>• the popular pressure exerted by the Anti-Apartheid Movement.</li> <li>• Answers might also note that the use of the word 'sidelines' implicitly acknowledges the role of prominent internal figures and/or factors such as Mandela and De Klerk.</li> <li>• <b>In analysing the limitations of the given interpretation</b>, answers might use knowledge and understanding of: <ul style="list-style-type: none"> <li>• the internal resistance of the ANC</li> <li>• the impact of the state of emergency</li> <li>• the role of de Klerk and his reforms in bringing about the end of apartheid</li> <li>• unrest within South Africa and the problem of government control</li> <li>• the role of the Church and Church leaders</li> </ul> </li> </ul>

	<ul style="list-style-type: none"> <li>• Answers might contrast the 'international community' with changing international circumstances and consider the importance of the ending of the Cold War, which meant that the communist threat that the National Party said it was fighting, no longer existed. South Africa had also fought two expensive wars in Angola and Mozambique and that threat had gone with the end of the Cold War.</li> <li>• <b>Other interpretations that might be used in evaluation of the given interpretation are:</b> <ul style="list-style-type: none"> <li>• interpretations focusing on the role of individuals such as Mandela or De Klerk</li> <li>• interpretations that focus on the failings and lack of sustainability of the Apartheid state</li> <li>• interpretations that question the extent or impact of international action against Apartheid.</li> </ul> </li> </ul>
