- 4 Evaluate the factors which make a federal system of government suitable for a country. [50]
- 5 'Rights and liberties are not adequately protected today.' Discuss. [50]
- 6 Compare and contrast the ability of legislatures to check the executive. [50]
- 7 To what extent is the power of chief executives determined by their style and skills? [50]
- 8 Discuss the view that the power of judiciaries cannot be justified in a democracy. [50]


