Level 2 Document Presentation - 06978

Overview

In relation to the qualifications / suite as a whole

This Level 2 Document Presentation examination offers candidates an opportunity to extend their word processing skills and produce documents which include graphics, borders and organisation charts. It is a popular qualification, particularly in the Spring and Summer series.

General Comments

Specific to each level within a qualification

The work submitted by candidates was generally of a good standard. Most candidates had sufficient time to produce four complete documents, though sometimes proofreading was overlooked due to the time limit of 1 hour and 45 minutes. However, the majority of candidates produced attractive documents with relatively few errors.

Main errors were as follows:

Document 1 – display task

Candidates often failed to leave one clear line space above and/or below the text box. The incorrect font size was sometimes used for the WordArt text. Borders were occasionally omitted.

Document 2 – circular letter

Many candidates were unable to produce the tear-off portion of the document with a bottom margin of less than 4 cm. They also had difficulty in aligning the dotted lines accurately at the right margin. Some candidates did not use the prescribed OCR-produced letterhead.

Document 3 – multi-page document

Page numbers were often omitted from second and subsequent pages; the top margin of subsequent pages was sometimes incorrect, also incurring a penalty. A few candidates had difficulty in producing the organisation chart correctly.

Document 4 – form creation and completion

Spacing between sections and items proved to be the most challenging aspect of this document. Many candidates produced this document perfectly.
