THE QUALIFICATION

How do different business situations affect business decisions? This course equips students with the skills and confidence to explore in a well-rounded introduction to the subject. It will encourage students to make informed choices about a wide range of further learning opportunities and career pathways as well as develop life skills that enable them to become financially and commercially aware.

The course is designed to enable students to:

- Explore business concepts, business terminology, business objectives, the integrated nature of business activity and the impact of business on individuals and wider society
- Understand contemporary business issues and different types and sizes of businesses in local, national and global contexts
- · Develop as enterprising individuals with the ability to think commercially and creatively, to demonstrate business acumen and draw on evidence to make informed business decisions and solve business problems.

ASSESSMENT

The specification is divided into topics, each covering key concepts of business. The content is clear and logically laid out, whether you're from an existing centre or new to OCR, with a straightforward assessment model and marking criteria.

The assessment consists of two exams that are both 90 minutes long. Each one is worth 50% of the total GCSE. Both question papers have a section with multiple choice questions.

GCSE (9-1) ECONOMICS

IDEAL FOR:

Those studying economics for the first time. It aims to develop an enthusiasm that will encourage them to progress to further study in economics

PROGRESS TO:

A Level or other Level 3 qualifications, or on to an apprenticeship or work

9 (highest) to 1 (lowest)

PERFORMANCE POINTS:

THE QUALIFICATION

Designed to be engaging and relevant for today's students, this course provides a comprehensive introduction to economics drawing on local, national and global contexts.

The course introduces students to basic economic concepts and helps them develop the appropriate range of analytical, critical and reasoning skills to enable them to think like economists. It provides an excellent foundation for advanced study in economics.

ASSESSMENT

This is an externally assessed qualification, with two exams of 90 minutes each at the end of the course. Both question papers have a section with multiple choice questions.

Component 01 introduces students to the main economic agents, the basic economic problem and the role of markets, including the labour market and the importance of the financial sector.

Component 02 focuses on the main economic objectives, such as economic growth, low unemployment, fair distribution of income and price stability, and other roles of government. Other aspects are the importance of international trade and the impact of globalisation.

THE OUALIFICATION

An aspiration for many young people is to be self-employed and start their own business. The skills required for this, such as being able to work collaboratively and creatively, solve problems and have awareness of businesses and customers, are also those requested by employers.

We've created a qualification that allows your students to get to grips with key aspects of running small businesses with a focus on enterprise and marketing. To do this, we've consulted with teachers, employers and entrepreneurs to make sure your students gain the right combination of knowledge, understanding and transferable skills required for the 21st century.

ASSESSMENT

Students complete three mandatory units:

- Unit R067: Enterprise and marketing concepts
- · Unit R068: Design a business proposal
- · Unit R069: Market and pitch a business proposal

Unit R067 is a written paper that makes up 40% of the qualification. The other two units are NEA units. Those two units offer practical task-based assessment opportunities, alongside the examined unit which contains underpinning knowledge and understanding. This results in a focused qualification that complements a Key Stage 4 study programme alongside other vocational qualifications and GCSEs.

AS AND A LEVEL BUSINESS

THE QUALIFICATION

Central to both the AS and A Level qualifications is developing the knowledge and understanding of the key aspects of business decision-making and the impacts these have on the business and its stakeholders.

Each component looks at different types of business ranging from SMEs to national and international organisations. The emphasis is on what's important for businesses, the consequences of their actions and why these differ depending on size.

The stimulating specification content encourages students to develop their skills as independent learners, critical thinkers and decision-makers – all personal assets that can make them stand out as they progress to higher education and/or the workplace.

ASSESSMENT

All components are externally assessed and include synoptic assessment, so students will have an holistic learning experience and be able to apply concepts to different situations.

AS Level

For AS Level, there are two exams of 1.5 hours each at the end of the course:

- The local business environment (01)
- The wider business environment (02)

A Level

There's a simple, straightforward assessment structure with no coursework, just three two-hour examinations at the end of the course:

- Operating in a local business environment (01)
- The UK business environment (02)
- The global business environment (03)

THE QUALIFICATION

Our Economics AS and A Level qualifications encourage students to think as economists by fostering the relevant analytical, questioning and reasoning skills. They give students a solid grounding in micro- and macroeconomic concepts, which they can apply to a range of real-world issues and contexts.

Component 1 of both the AS and A Level focuses on 'microeconomics'. From a base of microeconomic theory, it enables students to discuss and evaluate how well this theory explains our observations of economic agents in the real world.

Component 2 of both the AS and A Level focuses on 'macroeconomics'. It provides students with the technical and analytical tools required to understand how the macroeconomy functions on both the domestic and global levels.

The A Level qualification also has a **Component 3**, focusing on themes in economics and offering an exciting opportunity for students to apply theories and concepts to up-to-date contexts.

ASSESSMENT

For both AS and A Level, there's simple, straightforward assessment with no coursework and a balanced set of short, medium and extended response questions. The AS Level is made up of two mandatory components. The A Level is made up of three mandatory components.

All components are assessed entirely through written examinations that are externally marked. The components are mandatory and examinations take place at the end of the course.

ABOUT CAMBRIDGE TECHNICALS

Cambridge Technicals are vocational qualifications at Level 2 and Level 3 for students **aged 16+**. They're designed with the workplace and progression to higher education in mind and provide a high-quality alternative to A Levels at level 3. Qualifications at levels 2 and 3 have a mixture of internal and external assessments and centres are allocated a visiting moderator.
