

**Source for Question 1**

The rule of law is perceived to be one of the most important principles behind any liberal-democratic state. Citizens of a state are considered to have an obligation to obey the laws of the state, and if they fail to do so the state is considered justified in punishing this law breaking. Political thinkers, however, differ over the purpose of punishment, and their ideas fall mainly into three categories: retribution, deterrence and rehabilitation. Each model places a different emphasis upon the purpose of punishment as well as prioritising the needs of the victim, state and offender.
