

Read **all** the sources below and use them when answering Question 1.

Source A: The Roles of the Prime Minister

The prime minister has too much to do. He has to provide the overall direction in which he feels the country ought to proceed, while at the same time he is expected to master small details about the NHS and other aspects of public policy in the UK. He needs to manage the media, parliament, party and the whole executive structure of the UK, while he is also expected to be a 'charismatic' leader of the nation.

Source B: The Limits to Prime Ministerial Power**Source C: Prime Ministerial Power**

While on the one hand there is a strong argument for giving the prime minister the powers needed to deal with major issues such as international terrorism and global warming, there are also worries that the office has become too powerful. The Lisbon Treaty, the invasion of Iraq and the military involvement in Afghanistan are often cited as examples of prime ministers taking decisions without properly consulting either parliament or the people.
