Information for OCR centres transferring to **new specification** **for first teaching in 2008**

This document maps the current A Level History specification to the new specification for first teaching in September 2008. It includes information on the changes, support available and an outline of the new specification. It is intended to help ease the transition for Heads of Department and Teachers involved in the teaching of History.

QCA Have stipulated that:

- Number of units required to achieve GCE A Level is to be reduced from six to four. This has helped us produce a more coherent and context based A Level.
- Coursework to be retained in History. Choice for candidates to follow their own areas of interest has been retained.
- Stretch and Challenge style questions to be introduced into A2 assessment. This initiative is designed to give learners the opportunity to demonstrate their potential, and to help universities differentiate between applicants.
