Sentences have limited coherence and structure, often being of doubtful relevance to the main focus of the AO. Errors of grammar, punctuation and spelling may be noticeable and intrusive. <b>[0 1 2 3 4 5]</b>	Candidates provide a sound level of understanding of a range of job roles of <b>two</b> key workers who are involved in promoting health, and describe thoroughly <b>two</b> preventative measures that they could apply; Candidates show a sound understanding of the implications of a current health promotion initiative; Limited ability to organise relevant material. Some appropriate terminology used. Sentences are not always relevant with material presented in a way that does not always address the AO. There may be noticeable errors of grammar, punctuation and spelling. <b>[6 7 8 9 10]</b>	Working accurately and independently, candidates provide in-depth knowledge and understanding of a range of the job roles of <b>two</b> key workers who are involved in promoting health, explaining <b>two</b> preventative measures that they could apply; Candidates show an in-depth understanding of the implications of a current health promotion initiative. Ability to present relevant material in a planned and logical sequence. Appropriate terminology used. Sentences, for the most part, relevant and presented in a balanced, logical and coherent manner which addresses the AO.
