## Introduction

OCR is offering new GCSEs for first teaching in September 2009.

We have improved the quality of our GCSEs for teachers and students alike. We've made improvements in two key areas: updated and relevant content and a focus on developing students' personal, learning and thinking skills.

In addition and in response to reforms announced by the Government and in response to Ofqual mandated changes to GCSEs, unitised assessment of this qualification is being replaced by linear assessment from September 2012. This means that candidates commencing a two year course from September 2012 will take all of their GCSE units at the end of the course in June 2014.

#### The main changes are:

- Controlled assessment and examinations will be summative
- Examinations provide opportunity for extended writing and more varied question types
- All GCSEs will meet the requirements of the Equality Act.

OCR offers a range of support materials, developed following extensive research and consultation with teachers. We've designed them to save you time when preparing for the specification and to support you while teaching them.

It is important to make the point that this Teacher Handbook plays a secondary role to the specifications themselves. The GCSE Economics specification is the document on which assessment is based: it specifies what content and skills need to be covered. At all times therefore, the Teacher Handbook should be read in conjunction with the Specification. If clarification on a particular point is sought, then that clarification must be found in the Specification itself.

## Frequently Asked Questions

## What are the major changes to this specification?

- o The new economics specification consists of three compulsory units.
- The scheme of assessment is untiered.
- Unit A593 consists of pre released material, issued to centres prior to the examination.

### Will pre release stimulus material continue to be used?

Yes, for unit A593, where it will provide a broad context to aid preparation for the examination.
Pre-release material will be issued in the January prior to the examination.

### Will OCR make past papers available?

- o Papers are available to download from the OCR website.
- Only papers from previous exam series will still be available to download from the secure Interchange.

## What support can we expect from publishers?

- o OCR is working in partnership with individual publishers for different subject groups.
- o Comprehensive resources are being developed by these Publishing Partners, Heinemann, to support the specification and complement the support available from OCR.

## What support materials are being produced by OCR for the revised GCSE?

Schemes of work and lesson plans can be downloaded from the OCR website. The materials will be available in fixed PDF format, for reference purposes, and also in Word format, so that teachers can adapt the materials for their own use.

## Can learners re-sit the qualification?
