- 1 (a) Explain the differences between the covenants G-d made with Adam and with Jeremiah. [25]
(b) 'The covenants with Adam and Jeremiah have nothing in common.' Discuss. [10]
- 2 (a) Explain the features of Genesis 1:26–30 which led some scholars to describe these verses as a covenant between G-d and Adam. [25]
(b) 'Genesis 1:26–30 loses all significance unless it is accepted as historically true.' Discuss. [10]
- 3 (a) Compare the teachings about suffering in the books of Jonah and Job. [25]
(b) Assess which types of literature might best describe the books of Jonah and Job. [10]
- 4 (a) Explain the significant features of the experience of Elijah on Mount Horeb. [25]
(b) To what extent did Elijah learn more about the power of G-d on Mount Horeb than he did on Mount Carmel? [10]
