Option 1 – Raiders and Invaders: the British Isles c.400–c.1100

THE TASK

‘Everyday life was better for Saxon people than it was for Viking people.’

How far do you agree with this statement? Use your notes and source material, as well as your own knowledge, to explain your answer. [50]

How to do well

- Hint 1:** Do not write everything you know about Saxons and Vikings. This question is about making up your own mind about whether everyday life was better for people in Saxon or Viking times.
- Hint 2:** Decide which of your notes and source material are about everyday life and particularly about which groups of people had the best and worst lives.
- Hint 3:** Make sure you compare everyday life in Saxon and Viking societies, giving your views and supporting your views with evidence.
- Hint 4:** Remember to explain whether everyday life was better for Saxons or Vikings or whether it was equally good for both.
- Hint 5:** You should support your arguments with relevant evidence from sources and your own knowledge.
- Hint 6:** Your arguments should reach a conclusion that answers the question.

Option 2 – Power and Control: Kingship in the Middle Ages c.1100–c.1500**THE TASK**

‘King John treated people much better than King Edward I did.’

How far do you agree with this statement? Use your notes and source material, as well as your own knowledge, to explain your answer. [50]

How to do well

- Hint 1:** Do not write everything you know about King John and King Edward I. This question is about making up your own mind about whether one king treated people much better than the other.
- Hint 2:** Decide which of your notes and source material are about the treatment of people by the kings. Some of your material will be irrelevant to this question, for example, how successful each king was.
- Hint 3:** Make sure you compare how well each king treated people, giving your views and supporting your views with evidence.
- Hint 4:** Remember to explain why one king treated people much better than the other or whether they treated people similarly.
- Hint 5:** You should support your arguments with relevant evidence from sources and your own knowledge.
- Hint 6:** Your arguments should reach a conclusion that answers the question.
