## INTRODUCTION

### To achieve this unit, you must:

- research into working practices of a professional artist, craftsperson, designer, studio or organisation
- produce a personal investigation into professional practice, which will involve one or more art, craft or design specialisms
- complete your *statement of intent*
- present your final work for this unit in a format suitable for presentation to your client.

## GUIDANCE FOR CANDIDATES

### Research into the working practices of a professional artist, craftsperson, designer, studio or organisation:

You will need to understand the requirements and constraints imposed by professional practice.

All sources **must** be clearly shown or stated and copyright acknowledged.

### Statement of Intent

You must complete a *statement of intent* which clearly sets out the creative work you will produce, the resources you will use and the identification of possible constraints.

Your *statement of intent* should show your understanding of the process of professional practice and how it will inform the production of your creative work.

You may consider the following points when writing and researching your *statement of intent*:

- education, professional qualifications and career routes
- copyright and other legal issues
- the studio, workplace or environment in which you will create the work
- working alone or as part of a team
- materials/equipment required
- costings
- liaison with the client/target audience
- health and safety issues
- moral or ethical considerations.

Your *statement of intent* (signed and dated) must be submitted to your teacher **before** you start your creative work.

### Your creative work

This can be work which is:

- directly or indirectly related to **one or more** of your optional A2 units

**or**

- stand-alone/discrete.

Your work should fulfil all the requirements of your *statement of intent*. You will need to pay particular attention to documenting and recording the creative process and professional practice for assessment evidence.

You will need to present your final outcome(s) in a format suitable for presentation to your client.

### Evaluation

In your evaluation you need to respond to the following:

- how has the work of an artist, designer or craftsperson influenced the development of your skills and your work?
- how effective are the materials, processes and techniques you chose to work with?
- how well has the final outcome(s) satisfied the vocational requirements of being 'fit for purpose'?
- in what ways, in terms of modifications or alterations, would you adapt or change your final outcome(s)?

**All work must be clearly labelled with your name, candidate number, centre number, unit title and unit number.**
