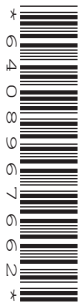

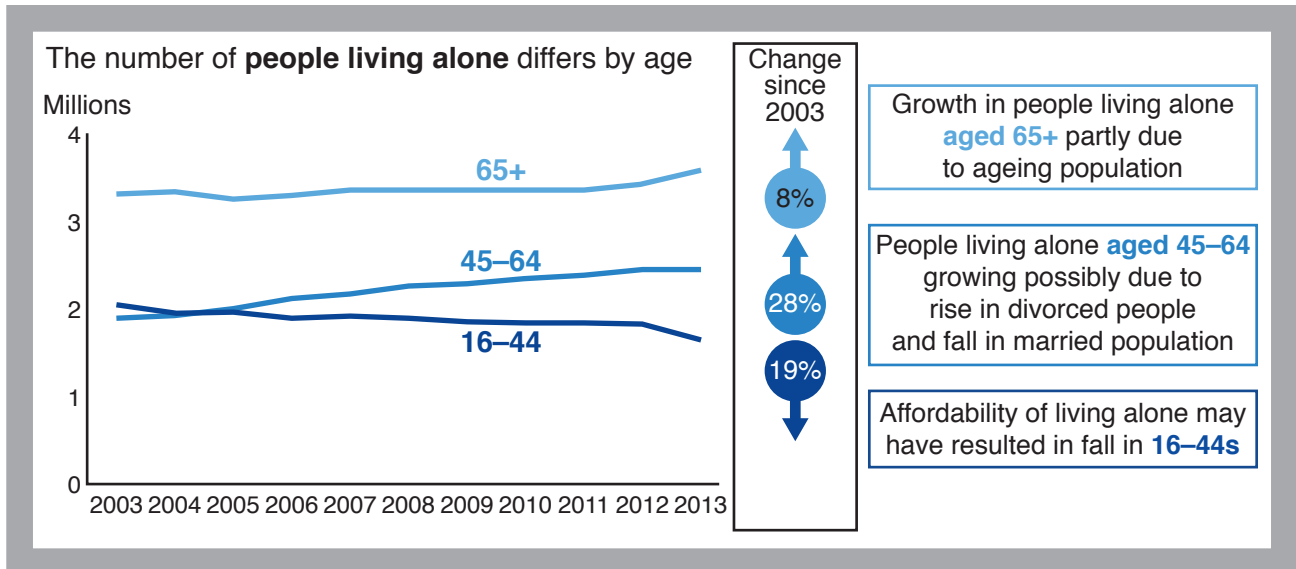

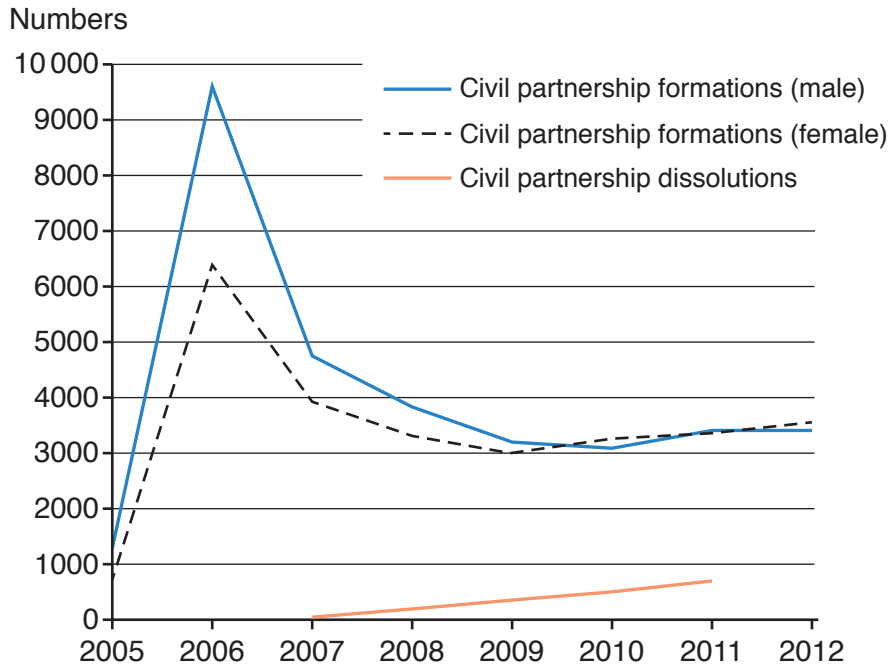

United Kingdom

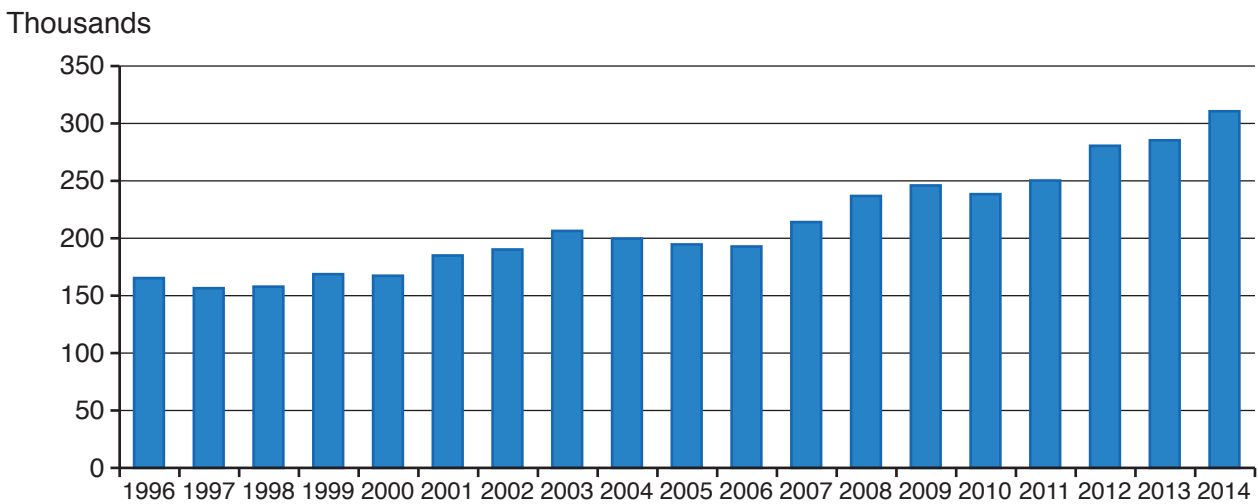
