1 Overview

The numbers offering this suite of qualifications has declined this year even though it is the only one out of three similar ones which provides a Level 1 qualification.

The decline has been particularly noticeable at Level 3.

The centres which have offered candidates have very largely paid close attention to the requirements of the schemes resulting in some good quality work.

The qualification closes in March 2018.

2 General Comments

10315 has been the most popular of the qualifications probably because it offers candidates who find academic work more challenging the opportunity to both obtain a qualification and also to possibly prepare themselves to go on to Level 2. Overall the standard of work has been high especially where it is clear that an IVQ has been used to check the work and to send it back for revision and/or addition if necessary.

10316 has, also, seen an improved standard of work for the same reason as above. Centres are encouraged to use this system because it saves the work being rejected and candidates being disappointed.

10317 has seen a very disappointing entry this year. It seems that the extra time needed for candidates to complete the course has deterred centres from entering candidates.

3 Comments on Individual Units

10315 Unit 4 – it has been pleasing to see that centres/candidates continue to understand exactly what is meant by a 'deal'.

Unit 6 – whilst most candidates complete Task 4 correctly there are still some who do not use the laws and plans as specified i.e. from Tasks 1 and 3. Others do this correctly, but then the 'describe how it will affect your plans' is very sketchy. Candidates should be encouraged to think this through carefully before committing words to paper.

Unit 7 continues to be unpopular, but the few examples which have been seen all have been of a high standard.

10316 Unit 11 has seen some very good work this year. The main problem has been that some candidates have been offering answers to Task 5.2 which are far too brief.

Unit 12 has also seen some good work, but few candidates appear to think about the preparation needed for a successful outcome to negotiations before the face to face work starts.

4 Sector Update

Government policy on getting people into work is still a positive factor in terms of these qualifications.
