

THE QUALIFICATION

These straightforward specifications focus on sociology's key themes: socialisation, culture and identity; and power, control and inequality. They provide your students with the exciting opportunity to gain a deeper understanding of the world around them and reflect on social issues that are often relevant to their own social experiences. They open up the possibility for fascinating discussions, for example, 'what impact do digital forms of communication have on social relations?', 'how do sociologists investigate inequality in society?' and 'what are the patterns and trends of religion in relation to social class?'

Through the specifications, students can acquire knowledge and a critical understanding of contemporary social processes and social changes. They have the opportunity to develop a broad set of key desirable skills, including the ability to analyse and formulate clear, logical arguments with scope for extensive evaluation from a range of theoretical perspectives.

We've integrated sociological theories and methods into each component. Although not directly assessed, we encourage students to carry out their own small-scale research projects as a way of enhancing their sociological understanding of methodology, substantive topic areas and core themes.

GCSE (9–1) PSYCHOLOGY

THE QUALIFICATION

This inspiring subject content provides a balance of classic and modern psychological theory and research that's relevant to young people today. There's an emphasis on the importance of practical work and 'doing psychology', and there are research studies on the specification that can be replicated. It provides applications to the real world, increasing students' psychological understanding.

This is a specification with a focus on mental health, encouraging greater awareness in young people and therefore reducing stigma and discrimination. It's been developed in partnership with Time to Change, England's biggest programme to challenge mental health stigma and discrimination, run by the charities Mind and Rethink Mental Illness.

This carefully-planned specification will also help your students to:

- Use specialist vocabulary, psychological concepts, terminology and conventions to engage in the process of psychological enquiry
- Understand how psychological research is conducted, including the role of scientific method and data analysis
- Develop an understanding of the relationship between psychology and personal, moral, social and cultural issues, and develop an understanding of ethical issues in psychology... and more.

ASSESSMENT

Students take both components 01 and 02, which are each assessed by a written paper.



AS AND A LEVEL PSYCHOLOGY

THE QUALIFICATION

Psychology is the scientific study of behaviour and the mind. It offers a unique educational experience that develops a distinctive and broad set of skills. It's located in scientific method and allows scope for extensive evaluation from a range of perspectives.

Stimulating content is at the heart of these engaging qualifications, which will encourage students to think like psychologists and gain a deeper understanding of psychology.

There's a practical approach to the study of research methods. This should prove popular with students, enabling them to gain hands-on experience of a range of different methods while developing evaluation skills and an understanding of research.

Our AS Level Psychology qualification is co-teachable with the first year of the A Level. The specification content is taken from components 1 and 2 of the full A Level qualification. For A Level, you and your students can also choose areas of specific interest to you from an exciting list, which includes criminal and child psychology.

ASSESSMENT

The specifications have a straightforward structure and assessment.

AS Level

Students must complete both components (01 and 02). The assessment consists of two written examinations externally assessed by OCR.

A Level

Students must complete all components (01, 02 and 03). The assessment consists of three written examinations externally assessed by OCR.

The three components are:

- Research methods (01)
- Psychological themes through core studies (02)
- Applied psychology (03)

THE QUALIFICATION

We've designed this qualification to enable students to understand and appreciate key citizenship issues at home, in school and as young citizens in their wider community. It also aims to deepen their knowledge of democracy and government, the law, rights and responsibilities and how we live together in society.

Our unique approach to subject content enables your students to learn with confidence from the start. The specification's first section is both familiar and interesting, and the content is organised thematically and progressively to motivate them and build on their existing knowledge and experience.

Our straightforward specification comprises three inter-related components:

- Citizenship in perspective (01)
- Citizenship in action (02)
- Our rights, our society, our world (03)

There's clear and comprehensive guidance to support your delivery.

ASSESSMENT

Students must complete all components (01, 02 and 03), each of which is externally assessed.

While you're free to plan your own route through the specification, our approach provides a clear, coherent package with built-in progression and continuity.

The subject content is split into four key sections. Each content section is supported by optional examples and suggestions for citizenship action. For this, students should participate in action in a real out-of-classroom context. Citizenship actions should be carefully planned practical activities that aim to deliver a benefit or change for a particular community or wider society. Questions on citizenship action will account for 15% of the marks for the GCSE (9–1) and it's assessed in component 02.

THE QUALIFICATION

Our engaging qualifications have been refreshed following the input of teachers and higher education stakeholders. We've designed the content to inspire your students, and foster their interest and enjoyment in law.

Students will gain knowledge and understanding of the English legal system and areas of both private and public law within the law of England and Wales. They'll also develop an awareness of law in a European and global context.

The qualifications will also help them learn how to apply the techniques of legal method and reasoning to analyse and offer answers to problems, based on legal principles, legislation and case law. They will also explore the changing nature of law and more in this broad yet manageable programme of study.

ASSESSMENT

These are clear specifications with a straightforward assessment model, backed up by specialist support and quality resources.

AS and A Level Law are assessed by written examinations.

- The AS qualification consists of two exam papers, each 1 hour 30 minutes long.
- The A Level qualification consists of three exam papers, each 2 hours long.

There's a variety of exam questions including essay and legal scenario questions.

The two components that students take at AS Level are:

- The legal system and criminal law (01)
- Law making and the law of tort (02)

At A Level, students take the same two components, as well as either the nature of law and human rights (03) or the nature of law and the law of contract (04).
