

## THE QUALIFICATION

Our Entry Level Certificate in Art and Design enables your students to develop creativity, imagination, communication and practical skills, and to express ideas, feelings and meanings through art, craft and design.

It offers five different areas of study to choose from. These cover the depth and breadth of art and design by providing options to use traditional methods as well as digital technology.

It's ideal to enable students of all abilities to access a qualification and grow in confidence. It also provides them with a perfect opportunity to progress onto further educational pathways such as GCSE (9–1) or vocational qualifications in art and design.

## ASSESSMENT

The specification enables students to progress at their own pace so they can develop their knowledge and skills and be put forward for the assessment when they're ready.

Our Entry Level Certificate is made up of 100% internally assessed tasks that can be taken at any point during the course. They're externally moderated by OCR.

### **There are two areas of assessment:**

- A portfolio (60% of the total Entry Level Certificate)
- An externally set task (40% of the total Entry Level Certificate)

The portfolio consists of a sustained project, theme or course of study. It may be presented in an appropriate format for this using, for example, annotated sketchbooks, mounted sheets, maquettes, prototypes, scale models or written work.

## THE QUALIFICATION

With so much choice, this specification enables your students to take a personal interest in why art and design matter and to be inspired and changed by an exciting and stimulating course of study. There's a selection of seven specification titles, which are listed opposite. They cover the breadth of art and design, both traditional and digital.

Each one is designed to encourage your students to develop knowledge, skills, and understanding along with creativity and imagination. They'll then show this through their responses to a range of visual and written stimuli. They'll also gain insight into the practices of individuals, organisations and creative and cultural industries. As your students develop artefact(s)/product(s)/personal outcome(s) that relate to their chosen title and area(s) of study, they can work entirely in digital media or non-digital media or a combination of both.

## ASSESSMENT

This specification encourages students to select, organise and present work that represents the best of their achievement.

### **There are two areas of assessment:**

- A portfolio, which is 60% of the total GCSE
- An externally set task, which is 40% of the total GCSE. In this, students respond to one of five themes, each with a range of written and visual starting points and stimuli)

Both components are 100% non-exam assessment and are 100% internally marked and externally moderated by visit.

## THE QUALIFICATION

The focus with these specifications is on encouraging students to develop skills, creativity, imagination and independence based on personal experience, taught skills and critical understanding. Students then show this through their responses to a range of stimuli.

We offer you a suite of specification titles that embrace current and emerging digital and other technologies including animation and games design, moving image and 3D digital design, as well as traditional routes such as drawing, painting and sculpture.

They provide an opportunity for your students to take a personal interest in why art and design matter and to be inspired and changed by studying a coherent, worthwhile course of study. They can also gain experience of the working practices of individuals, organisations and creative and cultural industries. These specifications provide freedom for your students to experiment and take risks with their work while developing their own style.

There's a 'framework' approach so your centre can design and develop courses appropriate to your own students, and that's broad enough to allow flexibility in delivery.

## ASSESSMENT

We've created a straightforward structure so you can focus on teaching creativity, rather than needing to spend time coaching students in how to navigate the assessment.

The AS Level has one personal investigation (portfolio) task.

The A Level has two components, one personal investigation (including a portfolio element) and one externally set task, with straightforward and easy to understand mark schemes. Both components are internally assessed and externally moderated.

## ABOUT CAMBRIDGE TECHNICALS

Cambridge Technicals are vocational qualifications at Level 2 and Level 3 for students **aged 16+**. This qualification has been designed so it can be delivered in one year.

These reflect the breadth of opportunities available in the art and design sector. Plus, your students have the opportunity to engage in a broader way through non-specialist units where, as an example, they might plan, research and develop ideas in response to a client brief, or plan and prepare for an exhibition for a collection of artwork.

With their exciting content, these focused qualifications complement a Key Stage 5 study programme alongside other vocational qualifications or A Levels or may constitute the bulk of a two-year study programme (depending on the size chosen).
