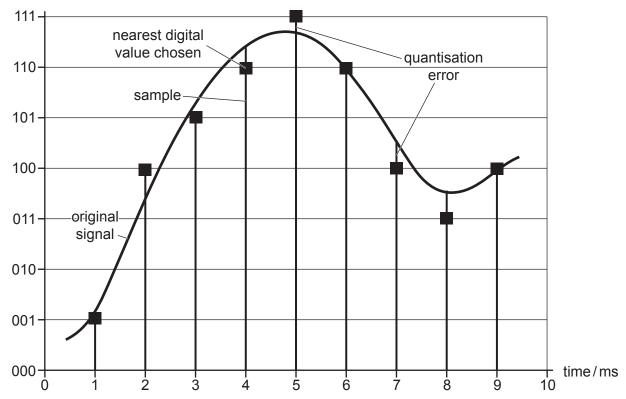

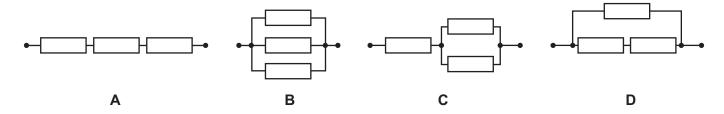

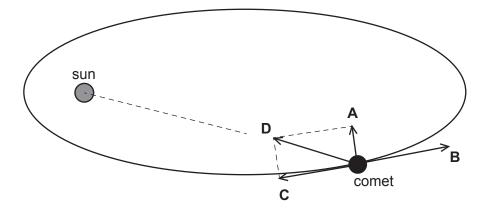

The diagram shows a comet in elliptical orbit around a sun.



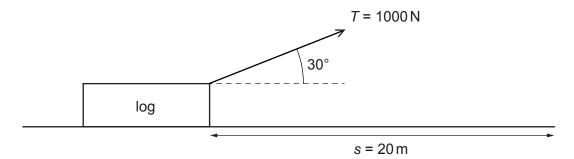

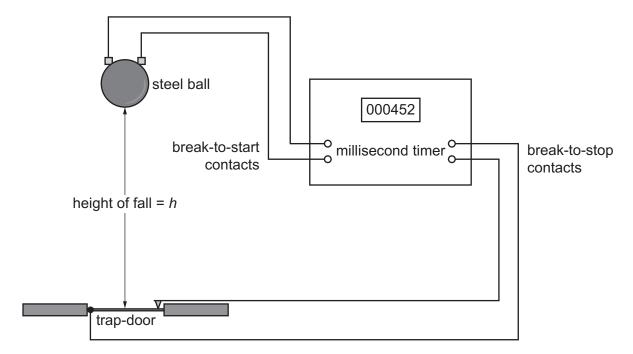

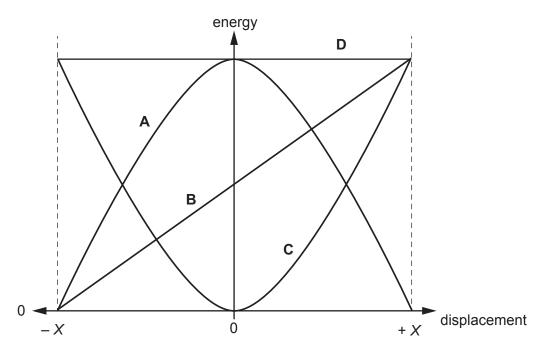

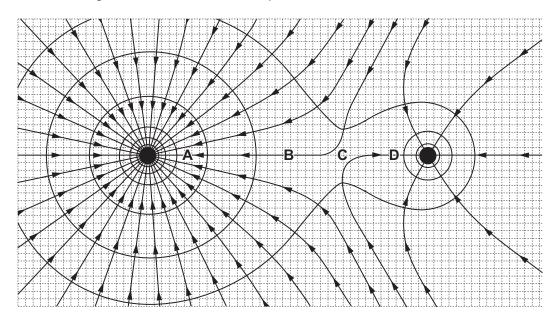

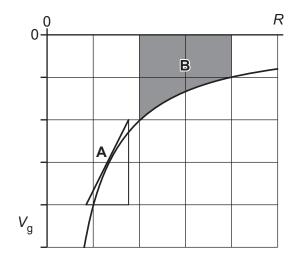
The diagram represents the gravitational field and potential for a planet – moon system. **A**, **B**, **C** and **D** are four points on the planet – moon line.

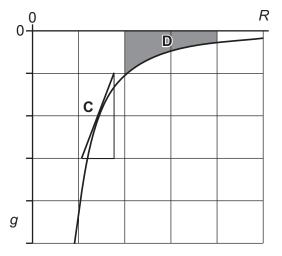

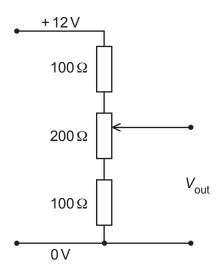

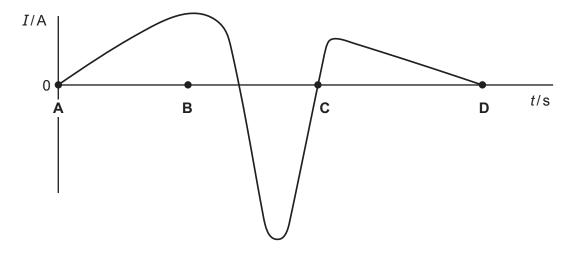

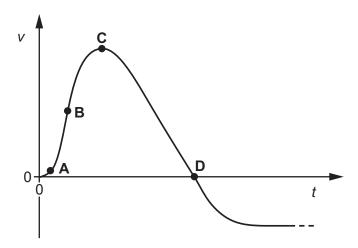

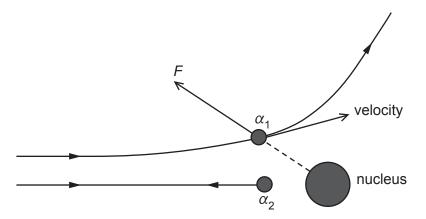

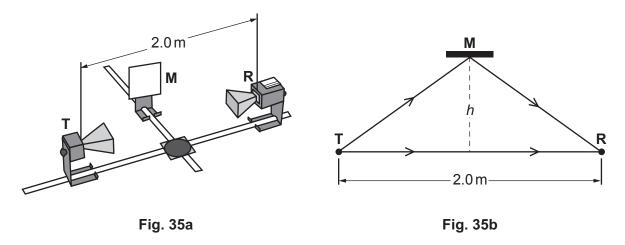

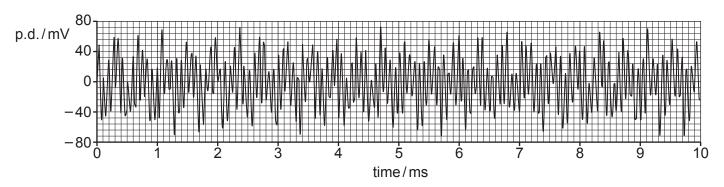

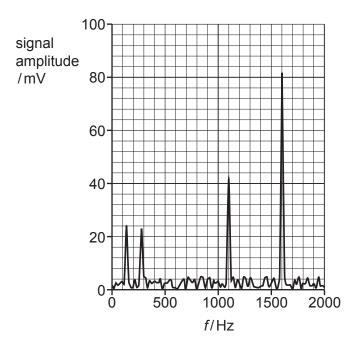

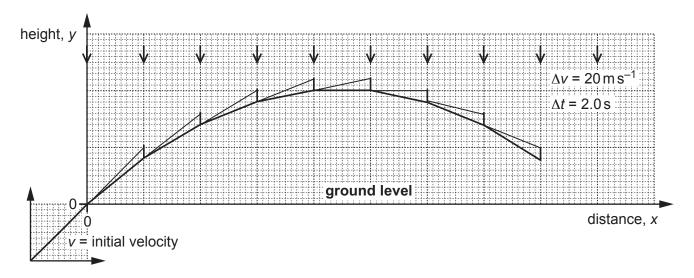

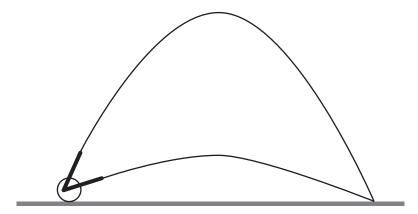


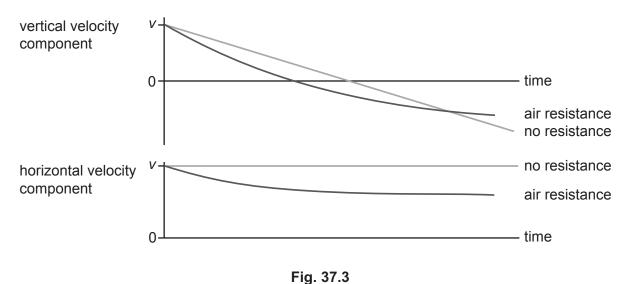
Fig. 37.2 (not to scale)

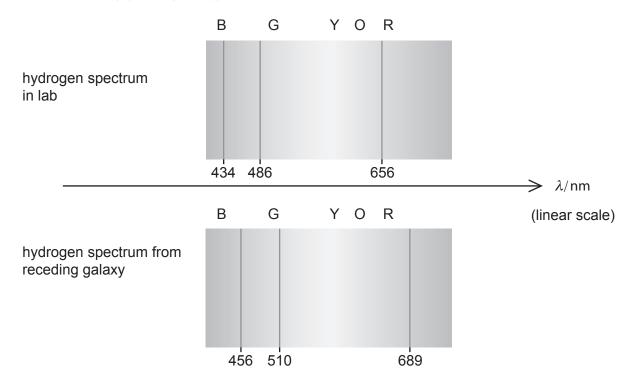

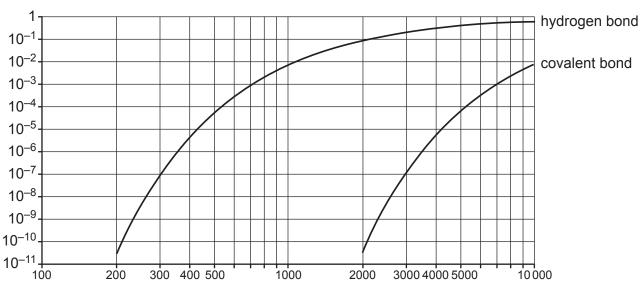

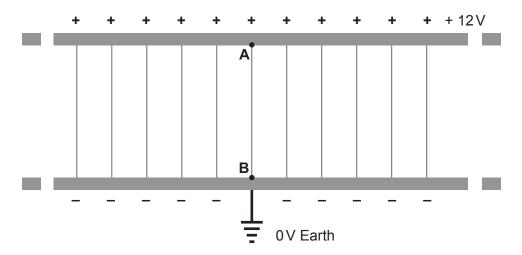

(b) Fig. 42.3 shows the circuit for an experiment that gives evidence that mercury atoms have a discrete energy level. Electrons are emitted from the heated filament and accelerate towards the anode grid through low pressure mercury gas.

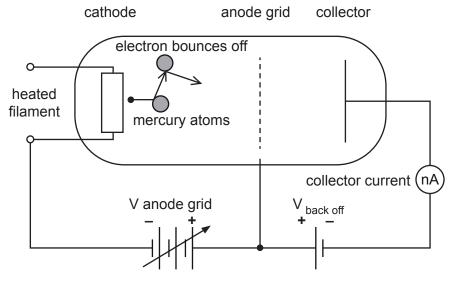

The electrons collide many times with mercury atoms on their way.

They pass through the open anode grid and, if they have sufficient kinetic energy, can climb the small potential hill provided by $V_{back\ off}$ ($\approx 0.2\ V$) to reach the collector. This flow of electrons registers as the collector current.

Fig. 42.4 shows how the electron current arriving at the collector varies with the voltage of the anode grid.

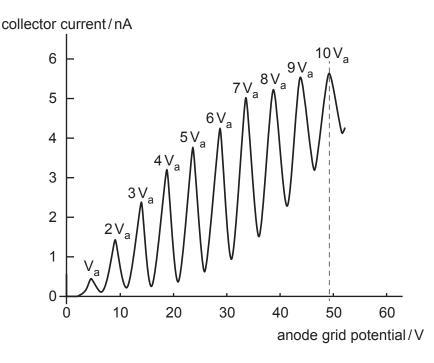
