- 1. Make sure that you have accessed and completed the relevant training packages for on-screen marking: *RM Assessor Assessor Online Training*; *OCR Essential Guide to Marking*.
- 2. Make sure that you have read and understood the mark scheme and the question paper for this unit. These are posted on the RM Cambridge Assessment Support Portal http://www.rm.com/support/ca

MARKING

5. Crossed Out Responses

Where a candidate has crossed out a response and provided a clear alternative then the crossed out response is not marked. Where no alternative response has been provided, examiners may give candidates the benefit of the doubt and mark the crossed out response where legible.

Rubric Error Responses – Optional Questions

Where candidates have a choice of question across a whole paper or a whole section and have provided more answers than required, then all responses are marked and the highest mark allowable within the rubric is given. Enter a mark for each question answered into RM assessor, which will select the highest mark from those awarded. (The underlying assumption is that the candidate has penalised themselves by attempting more questions than necessary in the time allowed.)

Multiple Choice Question Responses

When a multiple choice question has only a single, correct response and a candidate provides two responses (even if one of these responses is correct), then no mark should be awarded (as it is not possible to determine which was the first response selected by the candidate).

When a question requires candidates to select more than one option/multiple options, then local marking arrangements need to ensure consistency of approach.

Contradictory Responses

When a candidate provides contradictory responses, then no mark should be awarded, even if one of the answers is correct.

Short Answer Questions (requiring only a list by way of a response, usually worth only **one mark per response**)

Where candidates are required to provide a set number of short answer responses then only the set number of responses should be marked. The response space should be marked from left to right on each line and then line by line until the required number of responses have been considered. The remaining responses should not then be marked. Examiners will have to apply judgement as to whether a 'second response' on a line is a development of the 'first response', rather than a separate, discrete response. (The underlying assumption is that the candidate is attempting to hedge their bets and therefore getting undue benefit rather than engaging with the question and giving the most relevant/correct responses.)

Short Answer Questions (requiring a more developed response, worth two or more marks)

If the candidates are required to provide a description of, say, three items or factors and four items or factors are provided, then mark on a similar basis – that is downwards (as it is unlikely in this situation that a candidate will provide more than one response in each section of the response space.)

Longer Answer Questions (requiring a developed response)

Where candidates have provided two (or more) responses to a medium or high tariff question which only required a single (developed) response and not crossed out the first response, then only the first response should be marked. Examiners will need to apply professional judgement as to whether the second (or a subsequent) response is a 'new start' or simply a poorly expressed continuation of the first response.

- 6. Always check the pages (and additional objects if present) at the end of the response in case any answers have been continued there. If the candidate has continued an answer there, then add a tick to confirm that the work has been seen.
- 7. Award No Response (NR) if:
 - there is nothing written in the answer space

Award Zero '0' if:

anything is written in the answer space and is not worthy of credit (this includes text and symbols).

Team Leaders must confirm the correct use of the NR button with their markers before live marking commences and should check this when reviewing scripts.

- 8. The RM Assessor **comments box** is used by your team leader to explain the marking of the practice responses. Please refer to these comments when checking your practice responses. **Do not use the comments box for any other reason.**If you have any questions or comments for your team leader, use the phone, the RM Assessor messaging system, or e-mail.
- 9. Assistant Examiners will send a brief report on the performance of candidates to their Team Leader (Supervisor) via email by the end of the marking period. 12. Subject-specific Marking Instructions

Levels of Response targeting AO1 and AO2

Where a mark scheme targets marks at AO1 and AO2, there is no requirement for a response to be awarded in the same level for AO1 as for AO2, so for example a response could be awarded Level 3 for AO1 and Level 2 for AO2.

Set film not stated in an answer.

Where the set film has not been stated examiners should read through each candidate response fully. In the majority of cases it should be implicitly clear which set film the candidate is referring to through examples and references to sequences and characters. In this case the examiner can credit the answer appropriately against the mark scheme.

If it is not clear which set film the candidate has referred to then the candidate's response is limited to a maximum of the top of the middle level mark band.

If it is clear the candidate has not referred to a set film at all then zero marks should be credited.

INTRODUCTION

Your first task as an Examiner is to become thoroughly familiar with the material on which the examination depends. This material includes:

- the specification, especially the assessment objectives
- the question paper and its rubrics

This Mark Scheme is a working document; it is not exhaustive; it does not provide 'correct' answers. The Mark Scheme can only provide 'best guesses' about how the question will work out, and it is subject to revision after we have looked at a wide range of scripts.

The Examiners' Standardisation Meeting will ensure that the Mark Scheme covers the range of candidates' responses to the questions, and that all Examiners understand and apply the Mark Scheme in the same way. The Mark Scheme will be discussed and amended at the meeting, and administrative procedures will be confirmed. Co–ordination scripts will be issued at the meeting to exemplify aspects of candidates' responses and achievements; the co–ordination scripts then become part of this Mark Scheme.

Before the Standardisation Meeting, you should read and mark in pencil a number of scripts, in order to gain an impression of the range of responses and achievement that may be expected.

Please read carefully all the scripts in your allocation and make every effort to look positively for achievement throughout the ability range. Always be prepared to use the full range of marks.

INFORMATION AND INSTRUCTIONS FOR EXAMINERS

- The co-ordination scripts provide you with *examples* of the standard of each band. The marks awarded for these scripts will have been agreed by the Team Leaders and will be discussed fully at the Examiners' Co-ordination Meeting.
- The specific task–related indicative content for each question will help you to understand how the band descriptors may be applied. However, this indicative content does not constitute the mark scheme: it is material that candidates might use, grouped according to each assessment objective tested by the question. It is hoped that candidates will respond to questions in a variety of ways. Rigid demands for 'what must be a good answer' would lead to a distorted assessment.
- Candidates' answers must be relevant to the question. Beware of prepared answers that do not show the candidate's thought and which have not been adapted to the thrust of the question. Beware also of answers where candidates attempt to reproduce interpretations and concepts that they have been taught but have only partially understood.

	Candidates must reference two films: one British film and one US film.		
	The question requires candidates to discuss the impact of different viewing conditions and the effect this has on spectator response. Candidates will demonstrate knowledge and understanding of how the spectator is in dynamic interaction with the film narrative and film features designed to generate response. There should be reference to the different ways a film can be viewed at home, such as on television, gaming consoles, computers, tablets or other mobile devices and consideration of how choice of consumption technology can play a role in spectator response. There could be discussion of how environmental factors contribute to or inhibit spectator response. Some candidates may seek to compare spectator response in home viewing to when films are exhibited in cinemas and formats such as IMAX.		
	Candidates should refer to specific examples from their two chosen films in some detail and make reference to the micro- elements of film and how these are used to generate meaning and spectator response.		
	There should be a sense of coherence in the answer that reflects an overall understanding of the importance of spectacle and how visual effects are used, including the way that they are designed to engage the spectator and generate an emotional response.

2* 'The development of digital film production and exhibition technologies opens up new possibilities for cinema.' Discuss this view in relation to examples from **one British film** and **one US film** you have studied. [35]

	Candidates must reference two films, one British film and one US film.
	The question requires candidates to discuss critically the impact of digital film making and exhibition on the cinema industry. Candidates are likely to discuss the use of digital production and exhibition and assess the impact it has had on cinema in both the US and the UK.
	Candidates will demonstrate knowledge and understanding of how digital technology has affected the production and exhibition of contemporary film. They will refer to specific scenes from the films they have studied and discuss in detail the impact of digital, such as the use of digital visual effects created in post-production and the way they are designed to engage the spectator and create an emotional response.
	There should be some discussion of the benefits/drawbacks of digital exhibition in traditional cinemas and candidates may also discuss IMAX screenings and how the development of streaming platforms, such as Netflix, Amazon Prime and Disney+, has enabled films to reach new audiences. The 'digital-first' releasing strategy employed since the start of the Covid-19 pandemic could be a fruitful area for discussion of issues about digital exhibition.
	Candidates may partly reject the statement and discuss the continued use of traditional film stock, but will acknowledge that digital production and exhibition has significantly impacted on the film industry in both the US and the UK.

	The question requires candidates to demonstrate knowledge and understanding of the micro-elements of film form and discuss how they are used to construct representations of reality.
	Candidates will consider aspects of the micro-elements of cinematography, mise-en- scène, performance and sound and assess how they are shaped by editing to construct representations of reality in the documentary film they have studied.
	Techniques likely to be discussed include stylised reconstructions, cross-cutting, sound effects, voiceover narration and music. Candidates will consider how the use of these elements shapes the film's narrative and generates spectator response. They may discuss how the creative use of micro-elements can manipulate spectators, encouraging them to adopt the outlook of the filmmaker and raising questions about 'truth' and objectivity in documentary film making. Candidates should refer to specific examples from the chosen film in some detail.
