## Introduction

Our examiners' reports are produced to offer constructive feedback on candidates' performance in the examinations. They provide useful guidance for future candidates.

The reports will include a general commentary on candidates' performance, identify technical aspects examined in the questions and highlight good performance and where performance could be improved. A selection of candidate answers is also provided. The reports will also explain aspects which caused difficulty and why the difficulties arose, whether through a lack of knowledge, poor examination technique, or any other identifiable and explainable reason.

Where overall performance on a question/question part was considered good, with no particular areas to highlight, these questions have not been included in the report.

## R051 series overview

After the significant disruption to teaching and learning during the last two years it was pleasing to see such a large cohort being entered for this series of R051, and while there were inevitably some candidates who struggled with the paper, there were at the other extreme candidates who performed extremely well and gained high marks.

This qualification, and particularly Sport Studies, has grown exponentially over the last few years, with centres becoming increasingly more adept and confident in their preparation of candidates for external assessment.

Moving forwards, it is important that the changes in the new specification, which commences in September 2022, are implemented rigorously.

The use of a table was a different way of testing candidate knowledge of national governing bodies and as such offered prompts to candidates in relation to the three areas of: promotion, development and infrastructure. However, while many candidates gained 2 or more marks, a number were still clearly unsure of the three elements that a national governing body might use to manage their sport.

Many candidates gained both marks available, covering a variety of points on the mark scheme. However, this was one of several questions where some candidates offered generic statements, such as 'lack of time' as one of their responses. Candidates should be aware that statements containing 'lack of' should be qualified in relation to the subject content in the question.

Not well answered by many candidates, with almost all failing to relate their responses to how England Netball is able to fund initiatives for over 50s. Numerous responses focused on the availability of concessionary sessions or transport, rather than how the governing body itself generates income to fund its initiatives. However, those who focused on the correct element in the question were easily able to access the 3 marks available.

A number of candidates identified a lack of disposable income, together with, insufficient time due to looking for work as reasons why Ben might not take part in regular sport. However, there were a significant number of candidates who did not accurately apply the focus of the question in their responses and simply cited generic barriers such as 'lack of time', 'lack of money', 'lack of transport' and 'lack of awareness' as reasons for Ben's lack of participation in sport.

Centres are advised to encourage candidates to avoid simply regurgitating such phrases without incorporating the focus of the scenario. So, the' lack of' comments above should read, 'a lack of time as Ben is looking for work', 'a lack of disposable income', 'not being able to afford transport' and 'a lack of awareness of the sports available'

It is important that realistic solutions to barriers are offered, with 'buy a car', 'get a job', 'get parents to pay' being inappropriate solutions. In the same way that sufficient detail is provided in barriers quest questions relating to solutions should also fulfil the parameters presented in the question. For examp 'provide free or subsidised sport sessions' is creditworthy, while 'offer discounts' offers no detail as to what is being discounted.	ions, ole,

Emerging sports are already in existence and are already visible in the public domain. There are many CrossFit clubs in the UK, with some evidence of media coverage. However, the question is asking candidates to suggest how this participation can be increased, a factor that was not always addressed in candidate responses. So, 'media coverage' requires 'increased media coverage'. 'Advertise clubs' requires 'increased advertising or promotion' A number of candidates referred to role models as a factor to increase participation but simply wrote the term 'role models'. Such a statement is too vague and candidates should describe how role models might be used to help increase participation in CrossFit.

In any question requiring candidates to identify factors, the factor must be listed exactly as in the specification. For example, 'media' on its own is too vague, whereas the phrase, 'media coverage' is creditworthy.

The description element of the question should illustrate how the factor impacts the popularity of women's football in terms of participation, spectatorship, and increased popularity and not simply describe the factor.

While (a) and (c) were generally well answered, there were nevertheless many candidates who offered the description of fair play as 'playing fairly', which is a repetition of the question. The answer to (b) is team spirit (as in the exemplar below), not teamwork, as was used by a significant number of candidates. (d) required candidates to relate their response to the local sports community, not simply the local community.

Generally well answered, with the main error for candidates who lost a mark being the identification of clapping and cheering their own child as one of their answers.

A number of candidates did not focus on the sport of rugby thereby losing marks by suggesting that the ball should be kicked out of play following an injury, a football rather than rugby example. 'Shaking hands after a game' lost a mark, where the mark scheme requires the identification of opponents to gain this mark. A further error for candidates was the suggestion that following a tackle (again football related) the player should help their opponent up... not exactly an example of sportsmanship when you have just fouled them!

As referred to previously, it is important that candidates identify the focus of a question, which in this instance was disabled people and direct their response more specifically. Generic statements such as 'lack of provision/awareness/access/facilities' are not specific and do not directly identify the barriers that a disabled person might face when attempting to participate in tennis.

Overall a well answered question, with many candidates gaining the maximum 3 marks available. One notable error for those who lost marks was the use of clipped responses such as 'tourism', 'transport' or 'more money', without the necessary detail required for a describe question.

Candidates are clearly quite comfortable with the concept of hosting a major sporting event, with a significant number gaining the 3 marks on offer. However, marks were lost by some candidates who did not focus on the emboldened word **after**, in relation to the major sporting event, citing problems with litter, crowds, terrorism and traffic, which are not relevant to drawbacks after an event but are likely to be experienced during an event.

There was a complete range of responses to this question, with some very good discussions of why performers might choose to use performance enhancing drugs while others don't, incorporating practical examples and a balanced approach towards both elements of the question. (See the exemplar, which illustrates part of a candidate's response.)

Centres should encourage candidates, when instructed, to incorporate appropriate and relevant practical examples as frequently as possible throughout their response, as failure to do so could reduce access to the higher level. Similarly, where a question requires candidates to visit more than one area in their response, failure to offer comments on both areas, thereby creating an imbalanced response, would again restrict access to the higher levels.

Dividing work into indented paragraphs allows candidates to check if they have covered all elements of an extended question and fulfils the grammar, punctuation and spelling focus in the assessment descriptors.
