### Introduction

Our moderators' reports are produced to offer constructive feedback on candidates' performance in the examinations. They provide useful guidance for future candidates.

The reports will include a general commentary on candidates' performance, identify technical aspects examined in the questions and highlight good performance and where performance could be improved. The reports will also explain aspects which caused difficulty and why the difficulties arose, whether through a lack of knowledge, poor examination technique, or any other identifiable and explainable reason.

Where overall performance on a question/question part was considered good, with no particular areas to highlight, these questions have not been included in the report.

#### Online courses

### General overview

This year has seen a growth in the number of centres and candidates using OCR Entry Level History. Existing and new centres alike seem to have adapted to the challenges of the specification well.

Given that the most impressive and positive aspects of Entry Level History are the opportunities and evidence of candidates gaining experience of skills, there have been some real signs of progress provided by some centres this year.

There has been an increase in the number of centres who have completed the Individual or Site Study as a PowerPoint. In many instances this has been used for the candidates to present their work to others in the class. This adds incentive to present the work well, but also gives an opportunity to develop presentation skills and possibly valid discussion of strengths and weaknesses in the work. To this end, we would not like to see the word limits of these studies being a restriction for those keen enough to want to do more. They should be viewed more as a recommendation.

At the other end of the scale, there did seem to be some centres who removed much of the challenge from these studies by giving their candidates a bank of statements to select from. While this work benefits candidates through scaffolding, provision of sources (short) and discussion, narrowing the task to this extent reduces the candidate's motivation.

A further positive has been the centres who have used the OCR set tasks but changed them to suit their own candidates. Entry Level covers a huge range of candidates and those centres making these types of changes know them best. The adjustments can be changing the subject matter, for example on the Crime and Punishment option, the Silent and Separate Prison system can be quite a challenging area and something like Transportation might be more appealing. Centres are advised to find sources to set equivalent tasks. Other changes might be relevant to the challenges the candidates face.

#### Administration

After the two-year break through Covid restrictions, there were several administrative problems in the return last year. Fortunately, these were virtually eradicated by a combination of last years' experience and the helpful reminders that centres were sent before the process started this year. Most centres now use the appropriate cover sheets and mark clearly to make it simpler for moderation to judge the validity of the marking. There also seemed to be more centres who managed the punctuality of delivering the moderation sample, either through the Repository or through the post.

## Marking

Most centres are in line with the agreed standards for marking the Thematic and Depth Studies using the OCR mark schemes. The Individual and Site Studies however still offer a rather more variable response, with a significant minority of centres still undermarking their candidates' work. These pieces of work should be quite challenging for the candidates, especially the second element of importance and where it is done well, even if by strong selection of evidence, marks should be given accordingly.
