- 1. Make sure that you have accessed and completed the relevant training packages for on-screen marking: *RM Assessor Assessor Online Training*; *OCR Essential Guide to Marking*.
- 2. Make sure that you have read and understood the mark scheme and the question paper for this unit. These are posted on the RM Cambridge Assessment Support Portal http://www.rm.com/support/ca
- 3. Log-in to RM Assessor and mark the **required number** of practice responses ("scripts") and the **number of required** standardisation responses.

MARKING

- 1. Mark strictly to the mark scheme.
- 2. Marks awarded must relate directly to the marking criteria.

5. Crossed Out Responses

Where a candidate has crossed out a response and provided a clear alternative then the crossed out response is not marked. Where no alternative response has been provided, examiners may give candidates the benefit of the doubt and mark the crossed out response where legible.

Rubric Error Responses – Optional Questions

Where candidates have a choice of question across a whole paper or a whole section and have provided more answers than required, then all responses are marked and the highest mark allowable within the rubric is given. Enter a mark for each question answered into RM assessor,

which will select the highest mark from those awarded. (The underlying assumption is that the candidate has penalised themselves by attempting more questions than necessary in the time allowed.)

Contradictory Responses

When a candidate provides contradictory responses, then no mark should be awarded, even if one of the answers is correct.

Short Answer Questions (requiring only a list by way of a response, usually worth only one mark per response)

Where candidates are required to provide a set number of short answer responses then only the set number of responses should be marked. The response space should be marked from left to right on each line and then line by line until the required number of responses have been considered. The remaining responses should not then be marked. Examiners will have to apply judgement as to whether a 'second response' on a line is a development of the 'first response', rather than a separate, discrete response. (The underlying assumption is that the candidate is attempting to hedge their bets and therefore getting undue benefit rather than engaging with the question and giving the most relevant/correct responses.)

Short Answer Questions (requiring a more developed response, worth **two or more marks**)

If the candidates are required to provide a description of, say, three items or factors and four items or factors are provided, then mark on a similar basis – that is downwards (as it is unlikely in this situation that a candidate will provide more than one response in each section of the response space.)

Longer Answer Questions (requiring a developed response)

Where candidates have provided two (or more) responses to a medium or high tariff question which only required a single (developed) response and not crossed out the first response, then only the first response should be marked. Examiners will need to apply professional judgement as to whether the second (or a subsequent) response is a 'new start' or simply a poorly expressed continuation of the first response.

- 6. Always check the pages (and additional objects if present) at the end of the response in case any answers have been continued there. If the candidate has continued an answer there, then add a tick to confirm that the work has been seen.
- 7. Award No Response (NR) if:
 - there is nothing written in the answer space

Award Zero '0' if:

• anything is written in the answer space and is not worthy of credit (this includes text and symbols).

Team Leaders/PEs must confirm the correct use of the NR button with their markers before live marking commences and should check this when reviewing scripts.

- Candidates' answers must be relevant to the question. Beware of seemingly prepared answers that do not show the candidate's thought and which have not been adapted to the thrust of the question. Beware also of answers where candidates attempt to reproduce interpretations and concepts that they have been taught but have only partially understood.

	Some of Aurangzeb's military campaigns were successful. For example, in 1669, the Jat Revolt broke out near Deli. Aurangzeb led an army to crush the rebellion. He punished the leader by cutting all his limbs off in public.				
	However, others were less successful. For example, he launched a campaign against the Marathas but could never fully defeat them. When the Mughals gained a Maratha fort it was usually via bribery and the Marathas re-gained them quickly. By 1705, Aurangzeb still had little control in the area. [THRESHOLD - 7 MARKS]				
	[Causation/ consequence] Aurangzeb's campaigns were partly caused by his religious policy. For instance, in 1669 he announced that Hindu temples would be demolished and in 1679 he imposed a Muslim ruler on the Hindu area of Marwar. These policies strained Muslim-Hindu relations and led to a Rajput rebellion. Aurangzeb sent his son, Akbar, to crush the rebels. After Akbar decided to join the rebels, Aurangzeb sewed deceit between Akbar and the Rajputs, who then abandoned Akbar.				
	Another reason was the <b>raids from the Marathas</b> . They were Hindus in the South who didn't have much land, but <b>employed guerrilla tactics, raiding towns and then retreating to the mountains</b> on the west coast. These raids continued throughout Aurangzeb's reign, and in <b>1687, he launched a full-scale campaign</b> against them in Karnataka. [9]

Explanations could consider: to demonstrate piety/ Muslim faith (e.g. by building Taj Mahal and Great Mosque at Delhi); grief following death of Mumtaz Mahal (beauty and elegance of Taj Mahal); showing off prestige/ authority (size, cost and splendour of palace at Delhi and Taj Mahal); care for the people/ improving infrastructure (e.g. hospitals, roads, schools); personal cultural tastes (love for architecture and Persian design);

This is why the Taj Mahal is so elegant, with its water channels, fountains and gardens representing gardens of paradise.		
	Shah Jahan also built the new capital city at Delhi. This was mainly to <b>show off his status and majesty</b> . For example, he built a <b>new palace</b> there, which he wanted to be <b>twice the size</b> of any other palace in the Empire. It cost <b>6 million rupees</b> , covered the area of 60 football pitches and included a marble throne. # Question 4* - 18 marks 'Babur was an impressive leader and ruler in the period 1526 to 1530'. How far do you agree? Give reasons for your answer. Guidance and indicative content Level 6 (16-18 Balanced argument; two valid explained points on each side OR three on one side and one on the other (2-2 or 3-1). Clinching argument = 18 marks, e.g. marks) In some ways I do agree. Babur was an impressive leader as he used clever tactics to win the Battle of Panipat. For example, he created a strong defensive position by positioning his troops between the town and the river, and using buildings, ditches and barriers of fallen trees and 700 carts to prevent attack. This shows his impressive skills as a leader because he made it very difficult for enemy forces to do any serious damage to his army during battle, even though they were outnumbered. Babur was also impressive in the way he won support. For example, he stopped drinking wine to enhance his Muslim identity and thus won greater loyalty from his soldiers. Breaking up his gold and silver wine goblets and distributing the pieces to poor Muslims won him further support. This was very important as, in 1527, Babur's army faced the army of the Raiput Confederacy, a Hindu led army. By uniting his soldiers around a religious identity, Babur was able to defeat the Confederacy. However, Babur's spending on his court and gardens was excessive. The luxury came at a heavy price. At one point his officers had to return one third of their salaries. His spending was a problem because he was never able to create an efficient administration capable of uniting his empire and raising the money he needed.. However, Babur was certainly an impressive ruler in how he fostered culture and knowledge. Babur built up a large library of rare books and precious manuscripts. Without this work, Akbar may not have been able to create the great library that existed in his time. Moreover, Babur contributed to literature himself, authoring the Baburnama. This is considered a great work of literature due to the honesty of the writing and the insights it gives into his military campaigns and political decisions. Babur, overall, was a more impressive leader than ruler. He was impressive on the battlefield and winning power. But once he had power, it is clear that his skills of organisation and administration were limited. He did have some impressive achievements in developing culture, but these were personal projects. Concentrating on these cultural projects prevented Babur from giving enough time to the administration of his empire. # Notes and guidance specific to the question set

It is possible to reach the highest marks either by agreeing or disagreeing or anywhere between, providing the response matches the level description. BUT to achieve the highest **two** levels answers must consider both reasons to support and reasons to challenge the statement.

Answers are most likely to show understanding of the second order concepts of diversity, cause and consequence, but reward appropriate understanding of any other second order concept.

Grounds for agreeing include: Akbar's non-Muslim subjects benefited from his religious tolerance (he financially supported Hindu temples and built a large hall for religious debates, opening these up to include Hindus, Jains, Christians, Jews and Zoroastrians, who all had access to the Emperor). Akbar recruited more mansabdars (nobles) to serve him. They were granted lands/gained power through being given administrative and military responsibilities.

Grounds for disagreeing include: Akbar's open mind weakened the hold of **Sunni leaders** who were displeased with his toleration. He promoted Persian as the court language, which upset **Sunni clerics** who wanted Arabic to remain as the primary language: Akbar's rule did not benefit the **Sunnis** whose status and prominence was undermined. Akbar's reign also didn't benefit **poorer people**. His tax collection became a lot more efficient. He was taking between a third and a half of everything produced by the peasants.

### Question 5* - 18 marks

'All of Akbar's subjects benefited from his rule.' How far do you agree with this view of Akbar's reign (1556-1605)? Give reasons for your answer.

### **Guidance and indicative content**

His religious debates were viewed with suspicion by Sunni clerics who feared that it might lead to conversions away from Islam. Akbar also promoted Persian as the court language, which upset Sunni clerics who wanted Arabic to remain as the primary language of scholarship. So Akbar's rule did not benefit the Sunnis whose status and prominence was undermined.

Furthermore, Akbar recruited more mansabdars (nobles) to serve under him. Their number grew from around 40 to over 200 during his reign. They were granted lands gained from the Mughals' enemies. Alongside these men, Akbar also appointed mansabdars who gained power through being given administrative and military responsibilities across the Empire. So there were more educated people who gained from Akbar's reign through being given positions of wealth and power.

However, Akbar's reign didn't benefit poorer people. Akbar's tax collection became a lot more efficient. His officials produced records for each village, listing the size of fields, which crops were grown, and what the yields were. Tax had to be collected at specific times and paid in cash. Although this increased Akbar's revenues, it meant that he was taking between a third and a half of everything produced by the peasants, causing much suffering for people across northern India.

On the whole, historians of Mughal emperors have primarily focussed on Akbar's achievements in terms of his religious experiments and efficiency of administration. Although these policies were remarkable and helped to extend Mughal power, they actually benefited a very small number of people when compared to Indians in the majority of the population.

### Notes and guidance specific to the guestion set

Valid features that answers could identify include:

- Inferences from the source's content (L2) tells us that Germany is losing the war; that Frankfurt is under attack; that the Nazis are ordering ordinary citizens to defend the cities against the Allied troops; that the Nazis will not tolerate any kind of surrender and are determined to defend to the death.
- Inferences from the source's purpose (L3): The fact that
  the Nazis have published this poster tells us that the
  German people's morale required boosting as Germany was
  losing the war; tells us that the Nazis were very clearly
  worried about falling support for the war amongst German

There is no requirement to mention any possible limitations of the source. Candidates will be credited for recognising features of the source such as its production or tone and explaining how these are **helpful** to historians.

No reward can be given for raising concerns over the limitations of the source unless this is explicitly used to help to say what the source "can tell us" in relation to the focus of the question. No reward can be given for wider knowledge of the period that is unrelated to the topic in the question.

# Question 6 - 7 marks What can Source A tell us about Germany towards the end of the Second World War? Use the source and your own knowledge to support your answer. **Guidance and indicative content** Level 3 (6-7 Explains how the source's purpose reveals low morale/ falling support for the war effort, e.g. marks) This poster is trying to get German people in Frankfurt to rally behind the war effort and get ready to defend Frankfurt from the Allies. We can see this because the poster shows a German family looking determined and holding the Nazi flag whilst the city crumbles around them. They look grim but ready to fight. The fact that the Nazis have published this poster tells us that the German people's morale required boosting as Germany was losing the war. (7) The source reveals that the Nazis were very clearly worried about falling support for the war amongst German people. That's why they have published this poster, to attempt to rally the population to put up a final defence against the Allied armies. (6) NOTE 1: Both green elements (falling support for war + purpose) need to be present for this level, i.e. candidate has examined the purpose of the source and from this has deduced falling support. JUST saying 'The purpose of this source is ...' = L1. No reward can be given for raising concerns over the limitations unless this is explicitly used to help to say how it affects usefulness for the context given. Evaluation of usefulness may also involve making valid substantiated suggestions of other lines of enquiry for which the collection may be useful, but the focus given in the question must also be addressed.

No reward can be given for wider knowledge of the period that is unrelated to the topic in the question.

### Question 7 - 15 marks

How useful are Interpretation B and Sources C and D for a historian studying Nazi control of Germany in 1933? In your answer, refer to the two sources and the interpretation as well as your own knowledge.

### **Guidance and indicative content**

### Level 5 (13-15 marks)

Supported inferences (support from sources) from content of two of B, C or D to explain why they are useful as evidence about Nazi control of Germany in 1933 (i.e. 2 x L4)

Two x Level 4 examples below (must be from 2 different sources/interpretations).

A very clear explanation of how D is useful evidence of how the Nazis attempted control by publicising their camps, e.g.

Source D is useful as evidence of how the Nazis controlled the population **through publicising their use of concentration camps.** We can see rows of prisoners lined up in their uniforms with shaved heads. Calling it an 'education' camp makes the threat clear – if people oppose the Nazis, they will end up here. So this shows the Nazis were **not keeping the camps a secret – in fact they used them in propaganda** like this **to make people conform.** 

#### OR

A very clear explanation of how C is useful evidence of how the Nazis' control of the press/ local communities was total/widespread, e.g. C is useful for revealing how the Nazis have achieved control of the press, right down to the tiniest local newspapers. Here, we can see that 'The Oberstdorf Village and Tourist News' has published the Nazi orders for carrying out the anti-Jewish Boycott. This shows that not even the smallest and most harmless papers were not allowed to publish freely, and were made to comply with Nazi propaganda.

NOTE 1: 'Very clear explanations' must make use of the source - place unsupported inferences in L3.

NOTE 2: (in relation to the 'OR' answers above): Answers with no valid comment on any other source (content or inference) = 13 marks.

NOTE 3: Place responses which make exactly the SAME inference about the control of the press from C and D in L4.

# Level 4 (10-12 marks)

Supported inference(s) (from source) from content of one of B, C or D to explain why it is useful as evidence about Nazi control of Germany, e.g.

#### Interpretation B

- Interpretation B is useful for showing that Nazi attempts at controlling Germany were successful. Hermann Schulze is worn down by losing his job and by the Gestapo's questioning and house searches that eventually he gives up trying to oppose the Nazis 'I'm done with all that'.
- **B** is useful for **showing how the Nazis monitored their opponents**. They even sent an SS officer disguised as a socialist to Schulze's house to test whether he really had given up political activity. When it becomes clear that Schulze was broken, they let him know they were still watching him.

#### Source C

- C is useful for showing how the Nazis controlled people by pressurising them [/used propaganda to pressurise people] to go along with their anti-Semitic actions. They have given out orders, published in the local press, that trucks with anti-Semitic banners must be driven through the streets.
- Source C is useful because it shows that the Nazis controlled the press. They have published orders in the local newspaper, telling people to follow their anti-Semitic policies.

#### Source D

- Source D is useful as evidence of how the Nazis used concentration camps to get rid of their opponents. We can see rows of prisoners lined up in their uniforms with shaved heads for 'early morning roll call'. They are being 'educated', suggesting they have refused to conform to Nazi policy.
- **D is useful for revealing how the Nazis have achieved control of the press.** We can work this out because the 'Munich Illustrated Press' have published a photograph of the inmates of the concentration camp at Dachau on their front cover, calling Dachau an 'education camp'. This plays down the brutality of the camp and makes it seem necessary, **showing that in June 1933, the paper was under Nazi control**.

# Level 3 Valid but unsupported inference(s) from content to explain why one or more of B, C, D are useful as evidence about Nazi control of Germany, e.g. (7-9 Interpretation B is useful for showing that eventually Nazis won control of the population by wearing down their opponents. marks) Interpretation B is useful because it suggests you couldn't get employment if you opposed the Nazis, so this was a method of control. Source D is useful for showing that the Nazis were sending their opponents to concentration camps. OR uses specific contextual knowledge to argue that one or more of B, C or D are useful or not useful because they are (un)reliable, e.g. Interpretation B tells us that the Gestapo guestioned Schulze twenty times. This is useful because I trust it – the Gestapo were the Secret Police. They tapped telephones and used networks of informers, so it's highly likely they tried break socialist opposition like Schultze in this way. I don't think Source D is useful because it calls Dachau an 'education camp'. This is not reliable because Dachau was actually a concentration camp, mainly for political prisoners at first. It used punishments like floggings and beatings. So in June 1934, squads of SS officers murdered Röhm and as many as 400 others. Doing this helped Hitler to gain total power because the army then swore an oath of loyalty to Hitler, giving him the support of a disciplined and elite force.

Overall, I disagree with the statement because I think violence was the most important method Hitler used to gain total power. Though the Emergency Decree did not itself use violence, Hitler used violence to capitalise on it in the following month during the elections. Additionally, although the Enabling Act was technically a new law, it would never have been passed through the Reichstag without the use of violence and intimidation.

Answers are most likely to show understanding of the second order concepts of significance (importance of ghetto formation and other policies); change (turning points/ change in nature/pace of anti-Jewish policy in this period); and causation and consequence (impact of policies on Jewish people) but reward appropriate understanding of any other second order concept.

### Grounds for agreeing may include:

- the invasion of the USSR in July 1941 and the use of the Einsatzgruppen could be considered the most important turning point as this saw the first move towards mass murder and the deaths of approximately 2.2. million people.
- use of Einsatzgruppen led to changes in the 'psychology' of the Nazis (cumulative radicalisation).

Grounds for disagreeing may include: other developments in anti-Jewish policies were more important, e.g.

- **1935 Nuremburg Laws** were an important turning point as they stripped Jewish people of their citizenship rights in Germany.
- A similar point may be made about subsequent anti-Jewish legislation which increased discrimination/ persecution and made life extremely difficult, both socially and economically – 282,000 chose to emigrate
- the **November Pogrom / Kristallnacht** was important as it signified an explicit move to state-sponsored violence against Jewish people and at least 20,000 Jewish men were sent to concentration camps
- the **move to ghettos** changed the level and nature of persecution of Jewish people, e.g. signified the attempt to physically segregate Jewish populations; ghettos affected more people as the policy coincided with the invasion of Poland where there were 3.5 million Jewish people; the conditions in the ghettos were terrible, e.g. in Warsaw ghetto. 15 people shared an apartment, outbreaks of typhus and 140,000 died in three years
- the **development of the 'Final Solution'** (decision taken over the autumn of 1941 and plans made for its implementation made at the Wannsee Conference in January 1942) was arguably the most important as this saw the development of the death camps (and the decision to murder all Jewish people in Europe), where approximately a further 3 million were murdered.

#### Question 9* - 18 marks

'The key turning point in the development of Nazi anti-Jewish policy was the use of the Einsatzgruppen in 1941.' How far do you agree with this view for the period 1935–1945? Give reasons for your answer.

### **Guidance and indicative content**

### Level 6 (16-18 marks)

Balanced argument; two valid explained points on each side OR three on one side and one on the other (3-1 or 2-2). Clinching argument = 18 marks, e.g.

I agree that the invasion of the Soviet Union and the use of the Einsatzgruppen in July 1941 was an important turning point. The Nazis sent mobile killing units, Einsatzgruppen, behind the German army as it moved through Soviet territory. They rounded up Jewish people, took them to secluded areas and forced the victims to dig large pits before shooting them. This was a hugely important turning point as it saw the beginning of the organised mass murder of Jewish people. By 1944, the Einsatzgruppen had murdered around 2.2 million people.

However, I think there were also other important developments before this point. For example, the **Nuremburg Laws of 1935** introduced a range of antisemitic legislation, such as banning marriage between Jewish people and non-Jewish people, **stripping Jews of German citizenship** and not allowing Jewish people to vote. This was an **important turning point because it took away all of the legal rights** the German Jews had as Germans. Anti-Jewish laws like this (and the laws which followed) **made life so unbearable** that thousands of people chose to emigrate.

Furthermore, the use of **ghettos** was also important. They were formed when Germany invaded Poland in September 1939 and created the General Government, where there were around 2 million Jewish people. They were forcibly concentrated into certain areas of towns, like in the **Warsaw Ghetto, where 445,000 Jewish people were cramped together in terrible conditions**. This was a key turning point **as it signaled an attempt to physically separate the Jewish population in terrible conditions** – 140,000 people died in three years in the Warsaw ghetto.

Lastly, it could be argued that the **development of the 'Final Solution'** over the autumn of 1941 was the key turning point. This was the decision to murder all Jewish people in Europe and led to the **establishment of the death camps such as Chelmno and Sobibor**. From 1942, Jewish people were taken from the ghettos to the death camps. They were then stripped before being gassed in chambers. This was a **significant development as the Nazis were able to carry out mass murder on an enormous scale**: approximately 3 million died in the death camps.

Overall, I agree that the use of the Einsatzgruppen was the key turning point for Jewish people living in Soviet territory because they were killed immediately and suddenly. However, in Poland, I think the key turning point was the development of the ghettos, because they made it much easier for the Nazis to carry out mass murder. This is because they had already separated the Jewish population from other people. Jewish people were physically and mentally cut off from the rest of the population.

## Level 5 (13-15 marks)

Balanced argument; three valid explained points (i.e. two on one side and one on the other) (2-1), e.g.

The Nazis sent mobile killing units, Einsatzgruppen, behind the German army as it moved through Soviet territory.
