Locations


The company is based in three locations around the town:

- a showroom in the town centre where:
 - sample pieces of furniture are displayed,
 - furniture is designed,
 - customer orders are taken;
- an office where the administrative staff, network team and servers are located;
- a factory where the furniture is manufactured.

The three locations are connected by dedicated fibre.

Each location has its own local area network with the internet accessed via the connection in the office. The hardware used in, and the connectivity between, each location is shown in Figure 1.
